1 Goals

The purpose of this document is to detail the XBRL US Schedule of Investments Taxonomy. This document extends the XBRL US GAAP Taxonomies v1.0 Technical Guide [TECH] and highlights where the XBRL US Schedule of Investments Taxonomy diverges from the XBRL US GAAP Taxonomies v1.0. The intended audience of this document is a technical user familiar with XBRL, other specifications and modules of XBRL, XML Schema, and the XBRL US GAAP Taxonomies v1.0 Architecture [ARCH].

2 Files

The logical model of the XBRL US Schedule of Investments Taxonomy follows that of the XBRL US GAAP Taxonomies v1.0. The XBRL US Schedule of Investments Taxonomy contains five disclosures and one document view. In the XBRL US GAAP Taxonomies v1.0, there is a schema for the US GAAP concepts (concepts in the disclosures) with related label and reference linkbase. Each disclosure has an entry point and related calculation, presentation and definition linkbases. Document views in the XBRL US GAAP Taxonomies are serialized with their own schema file containing concepts with related label, reference, calculation, presentation, and definition linkbases.

The XBRL US Schedule of Investments Taxonomy does not separate the concepts and linkbases for the disclosure and document views. The XBRL US Schedule of Investments Taxonomy uses the "Non-GAAP" taxonomies' model of the XBRL US GAAP Taxonomies v1.0.

6 Future Releases

This version of the XBRL US Schedule of Investments Taxonomy will be incorporated into the next release of the XBRL US GAAP Taxonomies. At that time it will be serialized according to the US GAAP model. This will include:

- Serializing the Schedule of Investments types with the US GAAP types
- Serializing the Schedule of investments roles with the US GAAP roles
- Serializing the disclosure concepts with the US GAAP concepts
- Serializing each disclosure view with its own schema and related linkbases for calculation, definition and presentation
- Serializing schedule entry points for Schedule of Investments (for all disclosure roles except Form SH)
- Serializing schedule entry points for Form SH
- Serializing the investment document view concepts in a separate schema with related linkbases for calculation, definition, presentation, labels and references
- Serializing entry points for the investment document view.
